The puppy you have purchased from Chalk Rock Kennels, Inc. is guaranteed to be healthy at the time of purchase. You must take the puppy to a licensed veterinarian within 48 hours of receiving him/her for a "wellness check-up". The puppy will be current on vaccinations and de-wormings at the time of purchase. It is the responsibility of the buyer to keep the puppy's vaccinations and de-wormings current for age appropriate procedures.

Deposit To Reserve Puppy

Chalk Rock Kennels, Inc. requires a deposit in order to hold a puppy for a buyer until the puppy can go to its new home. The deposit does go toward the purchase price of the puppy. This deposit is required to ensure the buyer is committed to the purchase of the puppy. The deposit is non-refundable in the event the buyer determines they no longer want the puppy or have chosen a different puppy. Chalk Rock Kennels, Inc. reserves the right to use our discretion on other circumstances that may occur to prevent the buyer from purchasing the puppy. A partial reimbursement may be determined appropriate based on the circumstance.

10-Day Guarantee

Chalk Rock Kennels, Inc. guarantees the puppy for 10 days from the date of receipt against parvovirus, distemper, leptosporosis, hepatitis, par influenza, corona virus and bordetella. If your puppy contracts any of these diseases within the ten day period, Chalk Rock Kennels, Inc. must be contacted immediately. If the puppy should die from one of these illnesses within the ten day period, Chalk Rock Kennels, Inc. must be contacted within three days of the death. A replacement puppy of the same breed and sex will be provided from the next available litter. Chalk Rock Kennels, Inc. must be provided a written veterinary statement as to the cause of death and the puppy must be posted at a major university.

ONE YEAR Guarantee

Chalk Rock Kennels, Inc. guarantees, for one year, against any hereditary or congenital disorders that may interfere with puppy's ability to lead a normal life. This one year guarantee covers such disorders as heart murmur, skeletal abnormalities, luxating patellas, hip dysplasia or blindness. In the event of any such occurrence, Chalk Rock Kennels, Inc. will replace the puppy under the same conditions as stated above, providing a written veterinarian statement is submitted to Chalk Rock Kennels, Inc. within ten days from the date of diagnosis stating the nature of the problem. All shipping costs for the replacement puppy is at the buyer's expense.

Both the buyer and the seller of the puppy, hereby understands that the buyer is responsible for any and all veterinarian costs of every kind and nature, after the date of purchase, including vaccinations and de-wormings. If for any reason there is an exception made, the buyer shall contact the seller, and the seller will have full say in determining if a refund will be given. Any amount agreed on in excess of \$50.00 (Fifty dollars) for a veterinarian bill must be given in writing from the seller, Chalk Rock Kennels, Inc., to be valid. No other guarantees are made or implied by Chalk Rock Kennels, Inc. except those stated in this written health guarantee. All guarantees are strictly on a replacement basis.

To validate this guarantee:

This guarantee **MUST** be signed, dated and returned to Chalk Rock Kennels, Inc. prior to the puppy being shipped.
